COPY OF THE DEED DESCRIPTION

I, the real property at Lane, Louisville, Kentucky, together with all ments thereon located in Jefferson County, Kentucky, which is more particularly d as follows:

Lot #19: Beginning at a point in the Northerly line of the tract of land conveyed to R.H.
